
Respected Sir,

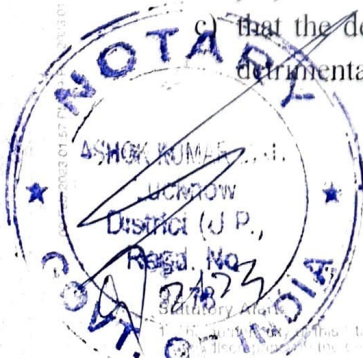



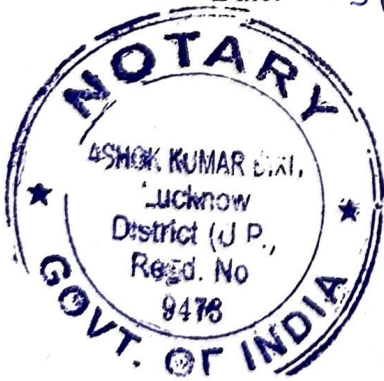
