CONDITIONS

In addition to the common conditions contained in rule 112 of these rules, this licence shall be subject to the following additional conditions:-

- 1) This licence is granted subject to all the provision of the Arms Act. 1959 and of the Arms Rules 2016.
- 2) It covers only the person named and the arms or ammunition described therein
- 3) The licence shall acquire and produce the arms together with the licence, within the time limit granted or extended as specified in coloum 9, before the licensing authority. If within the period so specified or extended the licensee fails to acquire the arms and to produce the licence or the arms or both, as the case may be the licence shall cease to be in force.
- 4) The licence, at the time of purchasing any arms or ammunition shall cause the following particulars to be endorsed upon his licence under the vendor's signature, namely-
 - (a) The Name, description and residence of the person who takes delivery of the articles purchased,
 - (b) The nature and quantity of the articles purchased, and

- (c) The date of purchase and if the arms of ammunition are purchased from any person other than a licensed dealer, shall also cause the particulars specified in clauses (b) and (c) to be furnished to the authority who granted this licence within such period as may be prescribed for this purpose by such authority.
- (5) The licensee shall not purchase ammunition of any kind in excess of the maximum prescribed both for the amount purchasable in a year and for the amount that may be possessed at any one time as laid down under rule 23 if, however, a licensee exhausts the total quantity of ammunition purchasable in a year earlier than the close of the year, he may for good and sufficient reasons be given a temporary increase in the total quantity purchasable at the discretion of the licensing authority to arms and ammunition dealer of a neighbouring state, by the concerned licensing authority for any reasons deemed appropriate and endorsement to this effect shall be made on the licence by such licensing authority.
