

- 1. The vacant and peaceful possession of the above described dwelling unit has been handed over to the Purchaser/Sub- Lessee. The Parishad/Lessor has received one-time Lease Rent of the Plot from the Developer and the Purchaser/Sub Lessee is not required to pay any Lease Rent to the Lessor during the Lease Period.
- 2. That the Sub-Lessee shall payprevailing taxes, charges, levies and impositions payable for the time being by the Lessee as occupier of the said dwelling unit, as and when, the same becomes due or payable. In addition, thereto, the Sub-lessee/Purchaser shall pay all other liabilities, charges for repairs, maintenance and replacement etc., as per Maintenance Agreement executed between the Sub-Lessee and Lessee or nominee of Sub-Lessee, as the case may be.
