**Subject: Request for being relieved from the post of Additional Civil Judge (Junior Division), Kaushambi under the provision of the U.P. Temporary Government Servant (Termination of Service) Rules 1975.** **Date: 01.09.2023**

Respected Hon'ble Madam,

With profound regards, it is most humbly submitted, that I was appointed as an officer in the Uttar Pradesh Judicial Services vide notification no. 4205 /Admin. (Services)/2019 dated 13 December 2019. Thereafter, I got transferred to district Kaushambi as Additional Civil Judge (Junior Division) vide notification no. 1304 /Admin. (Services)/2023 dated 28 April, 2023 where I am presently serving.

It is also humbly submitted that I had applied and appeared in Delhi Judicial Services Examination 2022 after taking the kind permission of the Hon'ble High Court of Judicature at Allahabad, at every stage of exam i.e., Preliminary, Mains and Interview. The copies of aforesaid permissions as granted by the Hon'ble High Court of Judicature at Allahabad vide online application ID No. S00018742022, S00021582022 and S00026342022, respectively, of Bulandshahar district have been annexed along with this application as Annexure **I, II and III**, respectively, for your kind perusal.

Pursuant thereto, I have been selected in Delhi Judicial Services Examination-2022, the final result of which was declared on 24.03.2023. Now, vide Memorandum No. F-6/6/2022-Judl./Suptlaw/805 dated 25.04.2023 issued by Government of NCT of Delhi, Department of Law, Justice and Legislative affairs, I have been offered appointment to the Delhi Judicial Services, which has been duly accepted by me on 27.04.2023. Copy of aforesaid memorandum has been annexed as Annexure **IV**.

I am honoured to inform your goodself that in pursuance of my acceptance to the said offer of appointment, I have been appointed in the Delhi Judicial Services via notification No. F. 6/6/2022-Judl./Suptlaw/1536-1542 dated 24.08.2023 issued Government of NCT of Delhi, Department of Law, Justice and Legislative affairs, copy attached herewith as Annexure **V**. Consequently, the Hon'ble High Court of Delhi has sent a letter no. 6153/DHC/Gaz.IIB/G-7/2023 dated 29.08.2023 to Hon'ble Allahabad High Court requesting you kindly to relieve me at the earliest so as to enable me to join the Delhi Judicial Services at the earliest.

I, therefore, most humbly pray your good self to relieve me from my duties having regard to the provisions of the U.P. Temporary Government Servant (Termination of Service) Rules, 1975, thereby enabling me to join the Delhi Judicial Services. I also humbly request that the issue of lien, over the present post, may be decided under the relevant rules, and that the notice period, if any, kindly, be waived. I shall be highly obliged to you for your kind consideration. I shall also be deeply grateful for the opportunities and guidance, which I have received in Uttar Pradesh Judicial Services. This experience will continue to guide me in my future endeavours. I am also thankful to the Institute of Judicial Training and Research, Lucknow for enlightening the judicial acumen in me.
