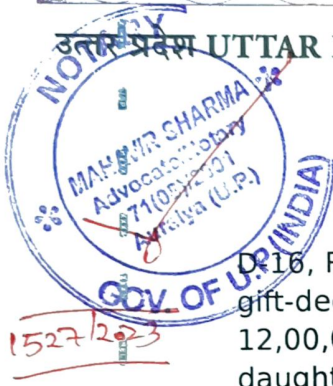
Gift Deed
