Subject- Submission of information/intimation regarding the purchase of movable property (Car) in accordance with the Rule 24 of the Government Servants Conduct Rules 1956.

Respected Sir,

I want to furnish the following information in the light of the **Circular Letter No. 25/ Admin. (A) dated 13th July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad. Sir, I want to submit that-

1. I joined the Uttar Pradesh Judicial Services on 15th November 2019 vide notification No. 4062/ Admin. (Services)/ 2019 dated 14th November 2019.
2. I was getting a Gross Salary of Rs. 1,08,085/- (One Lakh Eight Thousand Eighty Five) during the Month of May/June, while the Take Home salary was Rs. 91252 (Ninty Thousand two hundred fifty two) at that period.
3. I have purchased a new car on 16.06.2023 named 'Maruti Grand Vitara Delta CNG 1.5L 5MT BS6' from the reputed car manufacturing company 'Maruti Suzuki India Ltd.' from its dealership showroom 'BRIGHT 4 WHEEL SALES PRIVATE LIMITED, LUCKNOW located in Vikas nagar Ring Road Lucknow. Sir, the total price paid by me for the purchase of above-mentioned car was Rs. 15,42,595/- (Fifteen Lakhs Fourty two Thousand Five Hundred Ninty Five Rupees).
4. I have not taken any advance or the Loan from the Hon'ble High Court.
5. I took a Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) from the State Bank of India, PBB ASHOK NAGAR ALLAHABAD Main Branch to pay the complete amount to the dealer. The Loan Account No. for the same is **42004022698**. The Loan EMIs are payable for 84 month (7 years) at Rs. 21,000/- (Twenty one Thousand Rupees)/monthly. **(Shown in Annexure)**
6. I have purchased a new car.
7. The property purchased was a movable property of the description given in Point No. 3.
8. I have purchased the above-mentioned car from the reputed dealer "**BRIGHT 4-WHEEL SALES PVT.LTD., 11/CP-6, VIKAS NAGAR NEAR MINI, STADIUM RING ROAD LKO. 226022.**
9. Yes, the dealer is well known, reputed and regular Maruti Suzuki Car dealer of Lucknow and adjacent Districts.
10. No, the dealer is nowhere related to Me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.

I have made all the payments towards purchasing of the said vehicle from my Saving Bank Account No. 31451244068 of State Bank of India, Allahabad City/ ALLAHABAD UNIVERSITY

ALLAHABAD.

The whole amount was paid in following manner:-

- (i) Booking amount Rs. 11,000/- (Eleven Thousand Rupees) paid as Advance through UPI with transaction number 303383259157 to BRIGHT 4 WHEEL SALES PVT LTD.
- (ii) One instant Transfers of Rs. 50,000/- (Fifty Thousand) were made using the Account number of the dealership (50200018118056 HDFC bank). Transaction ID No. 316211704502 dated 11.06.2023. (Shown in Annexure).
- (iii) A Bank transfer of Rs. 1,00,000/- (One Lakh Rupees) was made by me using the Account number of the dealership (50200018118056 HDFC bank). Transaction ID No. 316622991038 dated 15.06.2023. (Shown in Annexure)
- (iv) A Bank transfer of Rs. 76,595/- (Seventy Thousands five hundred ninety five Rupees) was made by me using the Account number of the dealership (50200018118056 HDFC bank). Transaction ID No. 316622992991 dated 15.06.2023. (Shown in Annexure)
- (v) A Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) from the State Bank of India, PBB ASHOK NAGAR ALLAHABAD Main Branch to pay the remaining amount to the dealer. (As mentioned in Point No. 5 above)




