2. No study leave was availed as per Hon'ble High Court's C.L. dated 04.11.2011
3. Before joining of service on 18 June, 2018 the Officer appeared in the four papers out of six papers for LL.M.PART-I examinations conducted in offline mode in June, 2018.The officer could not appear for remaining two papers of LL.M Part-I examinations due to joining of service on 18 June, 2018 for which officer appeared in supplementary examinations held in December, 2018 after intimating to the Hon'ble High Court. (Offline letter dated 17.12.2018 is attached as stated above)
4. The officer could not appear in LL.M. PART - II examinations due to Induction Training programme at IJTR, Lucknow. The officer could not appear in the LL.M. PART - II supplementary examinations held in June, 2020 due to Covid 19 pandemic.The officer appeared in LL.M.
