**Sub.:** Intimation about buying a car


It is respectfully submitted that I bought a car after joining the service. The relevant details are furnished below:

1. I joined the service on 23<sup>rd</sup> January 2023.
2. My present gross salary is Rs.2,22,217 and take home salary is Rs.1,59,000/-
3. Before joining the service, I had two, two wheelers Bajaj Platina with registration number TN 05 BD 4944 purchased on January 2016 and Honda Activa with registration number TN05 AM 4811 purchased on January 2012.
4. No advance/loan taken from High court.
5. I bought a new Kia Carens 7 seater car on 16<sup>th</sup> February 2023 for an on road price of Rs.21,47,600. Downpayment was Rs.2,69,600/- and bank loan from Canara Bank was Rs.18,78,000/ for purchase of car. The loan was disbursed on 15<sup>th</sup> February 2024. Downpayment was made online and mode of repayment will also be online. The instalment amount of Rs.30,598/- will be deducted on 15<sup>th</sup> of every month and it shall be paid for a period of 84 months from 14<sup>th</sup> March 2023.
6. Not applicable.
7. Kia Carens 7-seater car bought on 16<sup>th</sup> February 2023 for an on road price of Rs.21,47,600 which includes registration, insurance and accessories.
8. Name and full address of dealer is Prem Wheels Private Limited, Branch 1: 26, Lakhanpur, Sikandra – Mathura Road, NH-2, Agra – 282007.
9. The dealer is regular and reputed.
10. I am not related to the seller and did not decide any of his case.

11. The downpayment was made online. Out of which an amount of Rs.1,49,600/- was paid from my savings and Rs.1,20,000/- by gift from my younger brother which was transferred online.

To substantiate the above said facts I enclose letter of gift from my younger brother, Proforma invoice, Loan sanction memorandum (Loan agreement), bank statement reflecting the payment (SBI and ICICI), payment receipts issued by the dealer and Registration Certificate. All the documents enclosed are self attested and certified to be the scanned copy of the original.

I was unaware that such an intimation should be submitted. Hence there was an inadvertent delay. I request your good self to kindly condone the delay in submitting the intimation.
