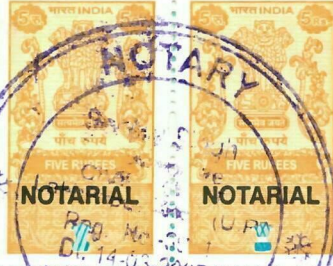

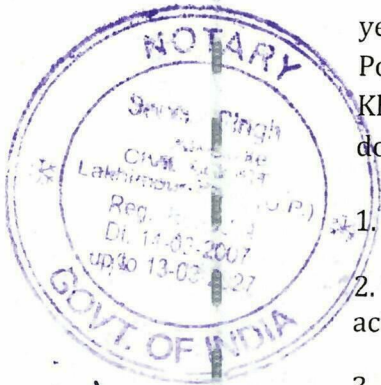

**AFFIDAVIT**

11. That, deponent has never visited any foreign country earlier.





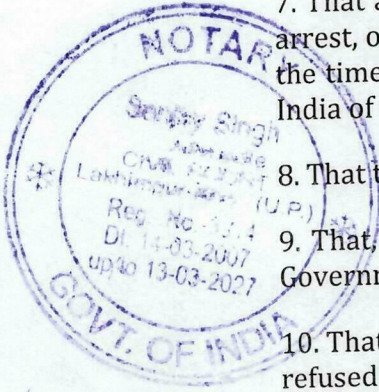
