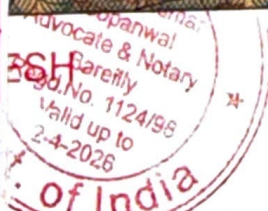
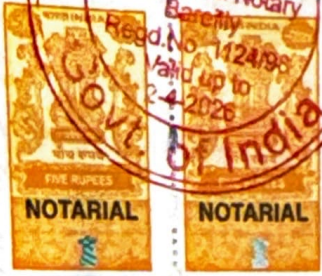

- 1- That the deponent is a citizen of India.

10- That the issue of 'Identity Certificate' for obtaining passport was never refused to the deponent.
