With reference to your letter no. 5844/IV-5694(Loose)/ Admin (A-4) / Dated 27-04-2024 on the above subject, this is to most humbly submit that the respondent is unable to submit the fresh application regarding permission to appear in last (IV) semester examination of L.L.M. course from University of Allahabad through e-Services portal only as per direction of Court's letter no. 558/XXXIII-CPC/e-Courts/Allahabad/dated: 31 August 2019 because she has freshly joined the services and her portal is not yet apceotional at the end of Hon'ble High Court's for which the report from the system officer is attached. Further, it is humbly submitted that respondent is a bonafide student of University of Allahabad for which certificate from Head of Department is attached. (Annexure-2). Also, the examination scheduled for IV (final) semester examination is duly attached (Annexure-3).
