- (HEIs), "Universities may offer courses in the ODL mode, without approval of the Commission, provided it satisfies all the conditions haid down under UGC (ODL) regulations, 2017 and amendments from time to time".

  2. - The HEIs cannot start or run any professional courses governed by specific Acts of
  Parliament, except with the prior and specific approval of the authority constituted
  there under. The professional courses prohibited are mentioned at clause [p] of Sub
  Regulations.
   As per the recommendations of Justice Reddy Committee constituted by MHRD on
  the directions of Honble Supreme Court dated 03-11-2017 in Civil Appeal No.
  17859-17870 filed by Orissa Lift Irrigation Corp. Lid Versus Rabi Sankar Patro &
  Ors. and its acceptance by the MHRD, the HEIs are informed that if any deviation is noticed, the same would entail not only withdrawal of permission / recognition for such ODL course but also for other courses offered by the institution, on regular and conventional mode.

- a) The HEIs shall strictly abide by all the provisions contained in the UGC (ODL) Regulations, 2017 and its subsequent amendments.

  b) The list will be updated from time to time on receipt of affidavits from HEIs under Category 1.
