

**C.L. No.25/ Admin.(A) dated 13th July, 1998**

**Regarding Purchase of movable/ immovable property by the judicial officers**

I am directed to say that all Judicial Officers be directed to furnish following information/papers to the Court while submitting application about information/grant of permission for purchase of movable property exceeding in value Rs. 10,000/- and immovable property, under rule 24 of the Government Servant's Conduct Rules 1956:-

- 1 Date of joining of Service. 08.05.2009
- 2 Present gross salary and take home salary. Gross-255645/-  
Take home-175790/-
- 3 Details of purchases(movable property exceeding to value Rs. 10,000/- and immovable property) made by him earlier with complete details, date of purchase, amount spent etc. Apartment 1585 square feet, Regd. on 12.02.2018 Amount Rs. 42,82,000/- (The permission to sell this apartment has been granted by the Hon'ble Court. The sale deed of the apartment will be executed in this month of June itself)
- 4 if any advance or loan taken from the High Court is amount and in what manner the loan will be repaid namely, the number of installments, its amount and till what date the deduction will be made etc. N.A.
- 5 If any loan taken from Bank etc. details of amount, mode of repayment, period of deduction, numbers and amount of installment etc. Rs.30,00,000/- loan from Canara Bank  
Top up loan- (i) Rs. 8,50,000/- (Emi Rs. 9,125/-)  
(ii) Rs. 5,00,000/- (Emi Rs. 6,596/-)
- 6 Regarding purchase of a second hand car name of vehicle, its model, cost price etc. date of first purchase (month and year) of vehicle from car dealer to the first purchaser and a copy of the insurance policy showing the amount for which the vehicle was insured prior to its purchase by the Officer. N.A.
- 7 Details of property (Area of plot, locality, City/District if building or flat then its size) Flat/House.151.55 sqmt.7, Lawrence Terrace colony, Lucknow.
- 8 Name and full address of the dealer/seller. (i) Avinash Jain S/o- Late Mr. Shikhar Jain and  
(ii) Smt. Sangeeta Jain W/o- Mr. Avinash Jain, R/o- 7 Lawrence Terrace colony, Lucknow

- 9 Whether the dealer is regular and reputed one. (Seller) No.
- 10 whether the Judicial Officer is related to the seller in any way and whether any case against the seller is pending in or decided by the Judicial Officer
- 11 Details of source of the amount with papers in support thereof. (i)-Amount of money received as arrears due to implementation of the VIIth Pay Commission's recommendation.  
(ii) Amount received after selling of the apartment at Deva Road, Lucknow.  
(iii) Loan of the remaining amount from the Bank.
