Sir, I want to submit that-


1. I joined the Uttar Pradesh Judicial Services on 1<sup>st</sup> January 2020 vide notification No. 4221/ Admin. (Services)/ 2019 dated 13<sup>th</sup> December 2019.
2. I was getting a Gross Salary of Rs. 150480/- (One Lakh Fifty thousand four hundred eighty only) during the Month of March/April, while the Take Home salary was Rs. 122137/- (One Lakh twenty two thousand one hundred thirty seven only) at that period.(Salary for the month of April, May and June not received till date )
3. I have sold my '**Hyundai Creta E+ (1.4 CRDI MT)**' **2017 model Reg UP78EZ2525** on 03.06.2024 to a reputed pre-owned car dealer Trust N Ride, New Jai Hero Ratanpur Akbarpur, Ambedkar Nagar 224146. Sir, the total price paid by the dealer for the sale of above-mentioned car was Rs. 557000/- (Five Lakh Fifty-Seven thousand).
4. I have not taken any advance or the Loan from the Hon'ble High Court.
5. I have purchased the above-mentioned car before the Joining of Judicial services on 30.09.2017 as a new car.
6. The property sold was a movable property of the description given in Point No. 3.
7. I have sold the above-mentioned car to a reputed pre-owned car dealer @trust N Ride, New Jai Hero Ratanpur Akbarpur, Ambedkar Nagar 224146.
8. Yes, the dealer is well known, reputed and regular pre-owned car dealer.
9. No, the dealer is nowhere related to Me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
10. I have received all the payments towards sale of the said vehicle in my Saving Bank Account No. 20018480760 of State Bank of India, Sanigawa Branch Kanpur Nagar. The whole amount was received in following manner:-
  - (i) 3 instant Transfers of Rs 547000/- was received on 03.06.2024 through bank transfer from Trust N Ride account. (RTGS and NEFT)
  - (ii) Rs 10000/- was received on 26.06.2024 through bank transfer from Trust N Ride account. (NEFT) after the completion of registration process from RTO.


