OFFER OF APPOINTMENT

Sub: Recruitment to the post of Public Prosecutor (Group 'A' Gazetted) in National Investigation Agency, New Delhi


On the recommendation of the Union Public Service Commission vide F.1/138(24)/2013-R.II dated 13<sup>th</sup> January, 2015 Shri Abhishek Kumar Bagaria S/o Shri Vinod Kumar Bagaria, resident of Bagaria Bhawan, Main Road, Ramkola, Kushinagar, Uttar Pradesh is hereby offered the post of Public Prosecutor (Group 'A' Gazetted) in the National Investigation Agency on the following terms :-

- i) The appointment is temporary and his case for confirmation will be considered in accordance with the rules in force, subject to the availability of a permanent post;
- ii) He will be on probation for a period of one year from the date of his appointment. The probation period may be extended at the discretion of the competent authority. During the period of probation his appointment may be terminated without notice and without assigning any reason thereof by the appointing authority. After the probation period is over, the temporary appointment may be terminated at any time by a month's notice on either side. The appointing authority, however, reserves the right to terminate the appointment forthwith or before the expiration of the stipulated period of one month's notice by making payment of pay and allowances for the period of notice or the unexpired portion thereof;
- iii) The scale of pay of the post is Rs. 15600-39100/- (Pay Band-3) plus Grade Pay of Rs. 5400/-. His pay will be fixed according to rules as recommended by the Union Public Service Commission.
- iv) He will also draw Court Allowance @ Rs. 1500/- per month, Robe Allowance @ Rs. 5000/- and Robe Maintenance Allowance @ Rs. 1200/- per annum.
- v) The appointment is purely provisional pending the issuance of eligibility certificate in the candidate's favour by competent authority and shall stand canceled in the event of such certificate being refused, in case of a person belonging to the following categories :-
  - a) a subject of Nepal; or
  - b) a subject of Bhutan, or
  - c) a Tibetan refugee who came to India before 1<sup>st</sup> January, 1962 with the intention of permanently settling in India, or

- d) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka or East African countries of Kenya, Uganda and the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire and Ethiopia or from Vietnam with the intention of permanently settling in India;
- vi) The appointment carries with it the liability to serve in any part of India under the National Investigation Agency.
- vii) He will not be entitled to traveling allowance for joining the appointment.
- viii) If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material/ information he will be liable to removal from service and such other action as Government may deem necessary;
- ix) Other conditions of service will be governed by the relevant rules and orders in force from time to time.
- x) The appointment of service will further be subject to :-
- a) Submission of declaration in the Form enclosed and in the event of the candidate having more than one wife living the appointment will be subject to him being exempted from the enforcement of the requirements in this behalf;
- b) Taking up an oath of allegiance/ faithfulness to the Constitution of India in the prescribed Form.

3. In case the offer is acceptable to Shri Abhishek Kumar Bagaria on the above terms, he may communicate his acceptance within 10 days of the receipt of this letter and report for duty to the Supdt. of Police NIA Branch Office Lucknow, A-4/47, Vishal Khand-4, Gomti Nagar, Lucknow within 01 month from the date of issue of this offer positively. If he fails to do so within the stipulated period, the offer of appointment made to him will be cancelled.
