Regarding the captioned subject, it is most humbly submitted that the Hon'ble Court through its letter no. 9691/IV-F-82(Pension)/Admin.(A) dated July 16, 2024 has been pleased to invite application in online mode on E-Services J.O Portal as well as in offline mode from all the judicial officials of State of U.P, who fullfill the criteria as laid down in aforesaid G.O dated 28.06.2024, as per proforma of Option Form , pertaining to opt for Old Pension Scheme.
