I want to furnish the following information in the light of the Circular Letter No. 25/Admin. (A) dated 13<sup>th</sup> July, 1988 issued by the hon'ble High Court of judicature at Allahabad, Sir, I want to submit that-

1. I joined the Uttar Pradesh judicial Services on 5<sup>th</sup> January, 2024 vide notification No. 02/Admin (Services)/2024 dated 2<sup>nd</sup> January, 2024.
2. I am getting a gross salary of Rs. 1,23,560/- (One Lakh Twenty Three Thousand Five Hundred Sixty Rupees) till this period.
3. I have purchased a new car on 11<sup>th</sup> June, 2024 named Hyundai Venue 1.2 Kappa MT S(O) SE, from the reputed car manufacturing company 'Hyundai Motors India Limited' from the dealership showroom 'JSV Motors and Constructions Pvt Ltd, located in CP-3/10, Vijyant Khand, Gomti Nagar, Lko, 226001, District Lucknow. Sir the total price paid for the purchased of the above-mentioned car was Rs. 1105000/- (Eleven Lakh Five Thousand Rupees only).

4. I have not taken any advance or the loan from Hon'ble High Court.
5. I took a car loan of Rs. 9,00,000/- (Nine Lakh Rupees) from the State Bank of India, Lucknow (PICUP) to pay the complete amount to dealer. The Loan account number for the same is 43049973973. The Loan EMI's are payable for 84 Months (07 Years) at Rs.14687 Monthly. (Shown in Annexure)
6. I have purchased a new car.
7. The Property purchased was a movable property of the description given in point no. 3.
8. I have purchased the above-mentioned car from the reputed dealer "JSV Motors and Constructions Pvt Ltd, Gomti Nagar, Lucknow having its registered address-CP-3/10, Vijyant Khand, Gomti Nagar, Lucknow, 226001.
9. Yes, the dealer is well known, reputed and regular Hyundai Car dealer of Lucknow and adjacent districts.
10. No, the dealer is nowhere related to me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
11. I have made all the payments towards the purchase of the said vehicle from my Saving Bank Account No. 34028209715 of State bank of India, Mainpuri Branch. The whole of the amount was paid in the following manner:-
  - A) Rs. 10000/- (Ten Thousand Rupees) paid using phone pay, UTR: 416009601850, Transaction ID: T2406081243410445880838 on 8<sup>th</sup> June, 2024.
  - B) One Instant transfer of Rs. 1,95,000/- (One lakh Ninety- Five Thousand Rupees) was made using Cheque of SBI, dated 11<sup>th</sup> June, 2024.
  - C) A car loan of Rs. 9,00,000/- (Nine Lakh Rupees) was taken from State Bank of India, Lucknow (PICUP) to pay the remaining amount to dealer. (As mentioned in Point No. 5 above)

Sir, the information furnished with above-mentioned content is being corroborated with annexed copies of A. Invoice Issued by the dealer, B. Copy of E-Passbook to my saving account no. 34028209715, D. The Registration Certificate issued by ARTO, Lucknow regarding purchased vehicle.

Sir, the delay if any caused in sending this intimation is due to delayed issuing of the Registration Certificate by ARTO, Lucknow and the delay caused on the part of the dealer regarding the issuance of Vouchers and Receipts. Kindly, condone the same.
