Sir,

With reference to your endt. nos. 1253/ I dated 09.07.2018 and 2724/ I dated 12.11.2019 on the above subject, I am directed to say that the Court has been pleased to grant permission to Sri Ashok Kumar, Spl. Judge (E.C.
