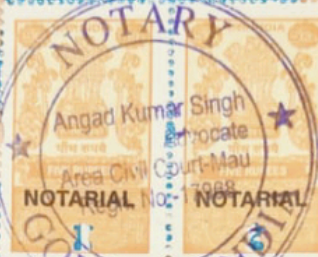

AFFIDAVIT

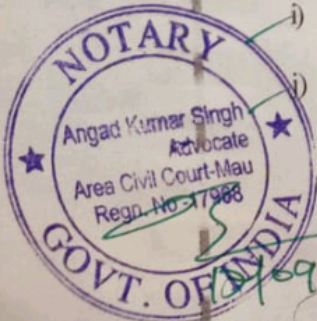
- That the applicant to a citizen of India.
- That the applicant may not or is not likely to engage outside India in activities prejudicial to the sovereignty and integrity of India.
- That the departure of the applicant from India may not or is not likely to prejudice the friendly relations of India with any foreign country.
- That the applicant has at any time during the period of five years immediately proceeding the date of her application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect there to imprisonment for not less than two years.
- That proceeding in respect of any offense alleged to have been committed by the applicant are not pending before any criminal court in India.
- That a warrant or summons for the appearance or a warrant for the arrest of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- That the applicant has not been repatriated.
- That there is no possibility of arising embarrassing position before the Government of U.P. due to her visit to any Foreign Country.
- That the issuance of "Identity Certificate" for obtaining a passport was never refused to her.
- That she has never visited any foreign country.
