**Subject:- Regarding exercise of option to opt for the Old Pension Scheme in furtherance of the option as has been invited vide U.P. Government's G.O. No. 14 / 2024 / सा-3-243 / दस- 2024/301 (1) / 2024, dated 28.06.2024.**

Sir,

In reference to the subject ceptioned above, it is humbly submitted that the undersigned has earlier vide letter No.1452/I dated 08.08.2024 sent the request eexercising the option to he covered by the old Pension Scheme. The option as has been sent in the prescribed format, has inadvertently not been endorsed by the office head (कार्यालयाध्यक्ष). The undersigned vide letter no.11718/IV-F-82(Pension)/Admin(A) dated 31.08.2024 has been directed to send the option in the prescribed format. In compliance of the same, the option is being resent in the prescribed format, as under:-

1. That, the State Government of Uttar Pradesh vide G.O. No. 14/2024/सा-3-243/दस-2024 / 301(1) 2024 dated 28.06.2024 has invited

applications from the employees of the State Government, who have been appointed against advertisement for recruitment issued/notified before 28 March, 2005 and who intend to opt for the old pension scheme.

2. That, the Uttar Pradesh Public Service Commission issued the advertisement bearing No.A-2/E-1/2003, therein notifying the Uttar Pradesh Judicial Service Civil Judges ( Junior Division) Preliminary Examination-2003, which was duly published in the weekly journal-

‘Employment News’ ( published by the Ministry of Information and Broadcasting, Government Of India) dated 22-28 November, 2003.

3. That, after due submission of the form, as per the terms and conditions mentioned therein, I was selected and recommended for appointment on the post of Civil Judge (Junior Division). Accepting the recommendation of the Uttar Pradesh Public Service Commission, the Hon‘ble Governor was pleased to appoint the undersigned and in accordance therto the Hon‘ble Highcourt of Judicature at Allahabad vide its notification no. 148 / DR(S) / 2006 Dated July 24,2006 was pleased to appoint the undersigned as Additional Civil Judge (Junior Division) at Allahabad District Court, which the undersigned joined on 31.07.2006.

4. That, the advertisement for the recruitment fo Civil Judges (Junior Division) in the Cadre of Uttar Pradesh Judicial Service had been published in November, 2003 i.e. well before the issuance of the notification for the implementation of the Newly Defined Contributory Pension Scheme (National Pension Scheme / System) on 28<sup>th</sup> March, 2005.

5. That, at the time of the appointment / joining of the undersigned as Additional Civil Judge ( Junior Division), the Old Pension Scheme had been discontinued and accordingly being covered by the Newly defined



Contributory Pension Scheme, the PRAN No. 110082056196 has been allotted to me, for which contribution has been made by me on a continuous basis.

6. That, in accordance with the choice extended vide the aforementioned G.O. No.14/2024/ सा-3-243/दस-2024 / 301(1) 2024 dated 28.06.2024, I, Submit my declaration of opting for the Old Pension Scheme, and thus intend to be accordingly covered by/under the Uttar Pradesh Retirement Benefit Rules,1961.

7. That, it is submitted that this is the final option being exercised by the undersigned to be covered for the post retiral benefits under the 'Old Pension Scheme' as is governed by the Uttar Prades Retirement Benefit Rules, 1961. Thus, I, declare my intent to forego the Newly Defined Contributory Pension Scheme i.e. N.P.S and opt for the Old Pension Scheme.

8. That , I am attaching herewith the option letter opting for the Old Pension Scheme, in the format prescribed by the G.O. No. 20 / 2024 / सा-3-276 / दस-2024 / 301 (1) / 2024, dated 11 July,2024.
