Earlier I wanted to purchase a penthouse at Vrindavan, Awas Vikas Yojna, Lucknow worth Rs. 75 lakhs for which I had paid Rs. 15 lakhs directly to the company through my saving account and Rs. 52 lakhs through loan of Canara bank. I paid EMI of Rs. 18,71,013 through my savings account. Concerning details of the above have been shared with the Hon'ble High Court with the Id No. -P00062892022 dated 29/12/2022. Due to some reason the deal could not be finalized and as per the


request of the company, I received a refund of Rs. 8064576 in the month of July on different dates from the company concerned in my savings account. Later on, I paid loan amount from the refunded amount and settled my bank loan accordingly.
