As per the Indian income tax rule Section 206C of the Income Tax Act has indicated the exhaustive list of goods

that are specified and should be collected TCS and paid to the government. According to this any foreign travel

will attract 5% TCS up to 7 lakh and above 7 lakhs 20% TCS will applicable. But this amount will be refunded/adjusted against the tax returns. NON pan holders are NOT eligible for tax adjustment/refund.
