Kindly place before the Hon'ble High Court and issue me "Identity Certificate/No Objection Certificate, mentioned above.

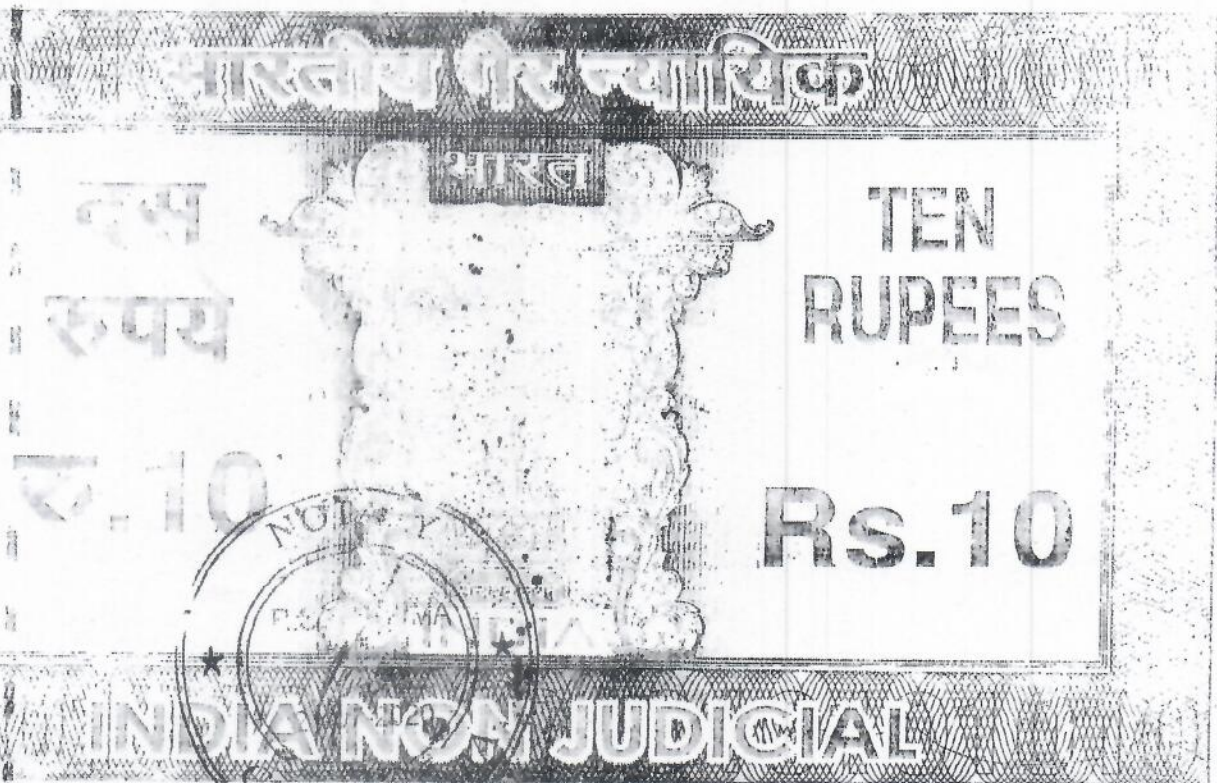

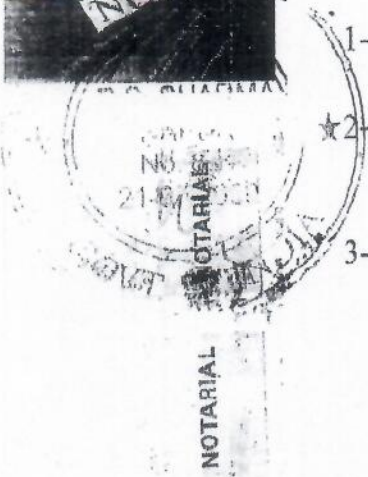
