Respected Sir,

With reference to your letter dated 03.08.2019(**no.10906/IV-4426/admin(A-4/ dated 19.08.19)**), the undersigned is hereby submitting detailed reply of the two points mentioned in the letter.

1- Cost of the Honda city (1.5VMT(I.VTEC) car at the time of purchase was rs 1175000(eleven lakh seventy five thousandonly), it's ex-showroom price was Rs 1023500.0 only

Out of the total amount , Rs 25000(twenty five thousand)was paid through cheque no 793627 dated 24th dec 2018(S.B.I) as booking amount , and Rs four lakh fifty thousand was paid as price through cheque no 793636 dated 24th dec 2018, and the rest Rs seven lakh was taken as car loan.

The payment of Rs four lakh seventy five thousand was made from the my salaried account.

2- Complete and self attested record of my salaried account of atleast one preceeding year before the date of purchase (obtained through internet banking) is hereby attached alongwith the letter for your kind perusal.

Entries regarding purchase of car are on date 24th and 27th december 2018.

Perusal of the entires will make it clear that from the date of joining till purchase of car on 29th dec 2018 , the undersigned has recieved a total of Rs 12,66719(Rs twelve lakh sixty six thousand seven hundred and nineteen only) as salary (**including D.A and I.R. and after all the deductions including income tax**)and out of that **the payment of Rs four lakh seventy five thousand was made from the my salaried account .**

No money is deposited /credited in the account which exceeds one month's salary of the undersigned.

The details of the loan along with it's relevant papers had already been sent to you.
