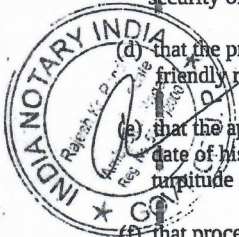

AFFIDAVIT

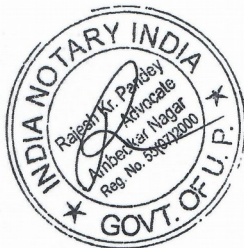
