

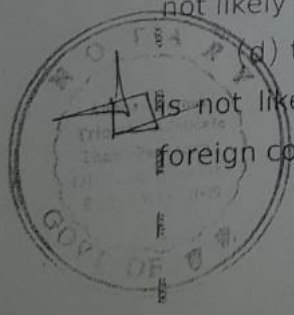

(f) that, proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal Court in India,

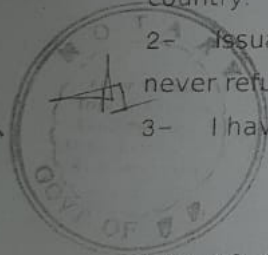
