Subject: - Regarding date of admissibility in matter of grant of three advance increments to Smt. Vineeta Vimal, Additional District Judge, Gonda on account of possessing degree of LLM.

Sir,

With reference to Hon'ble Court letter no. 12742/IV-3706/Admin (A) Dated 05.09.2019 on the subject cited above.

Most respectfully I, Vineeta Vimal, the applicant submit as follows:-

1. That I completed my LLM from Kurukshetra University, Kurukshetra through distance education. The details of which are as under:-
 - a) My registration number is **07-DE-690**
 - b) I appeared for LLM-Part-I Examination May, 2008(**Roll No. 0665718**) and passed (Copy of mark sheet dated 12.09.2008 is attached as **Annexure-A**).
 - c) I appeared for LLM-Part-II Examination May, 2009(**Roll No. 0246685**) and but could not clear one subject (Copy of mark sheet dated 09.09.2009 is attached as **Annexure-B**).
 - d) I appeared again (for subject which I could not clear earlier) in LLM Part-II Examination Dec. 2009(**Roll No. 0263616**) and passed. The result was declared 09.04.2010 {Copy of mark sheet dated 09.04.2010 is attached as **Annexure-C**}.
 - e) LLM Degree was awarded to me(**Sr. No. 1404**),, where the date has been mentioned as **March 31, 2010**(Copy attached as **Annexure-D**)
2. The LLM Part-II/Final result was declared on **09.04.2010** and mark-sheet dated **09.04.2010** was issued. But the date of award of **degree** was mentioned as **March 31, 2010**. Thus giving rise to ambiguity as to how the issuance of degree can pre-date declaration of final year Result/Mark-sheet.

Most respectfully I, **Vineeta Vimal D/o Sh. Suresh Chand Vimal**, the applicant submit as follows:-


1. That I completed my LLM from Kurukshetra University, Kurukshetra through distance education. The details of which are as under:-

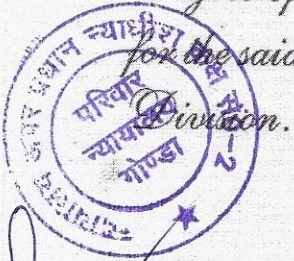
