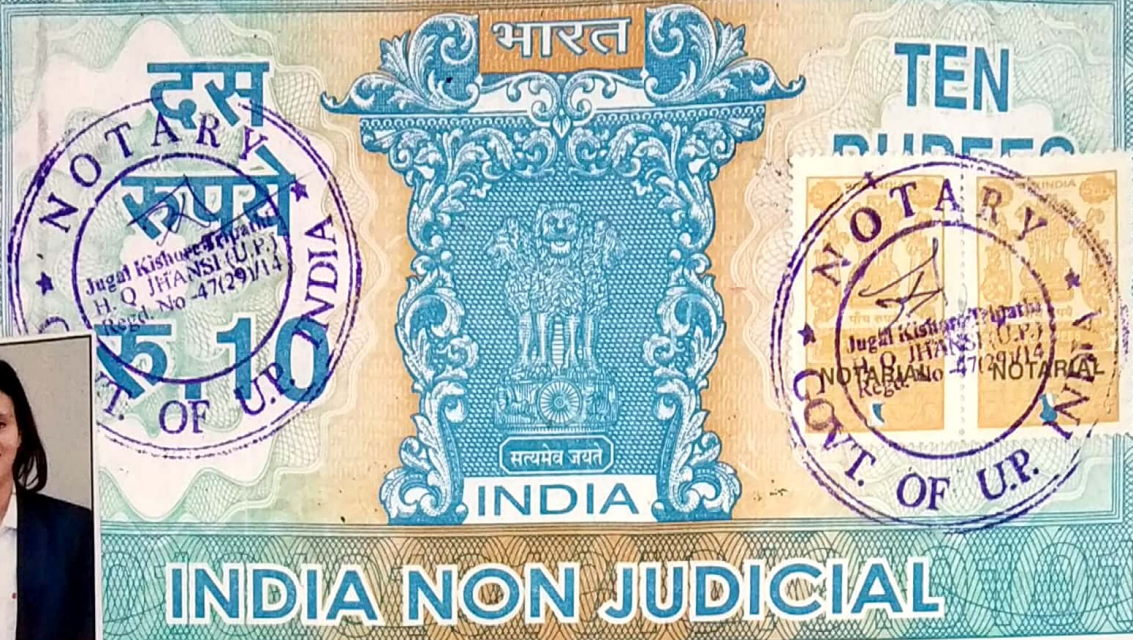

- g. That a warrant or summons of or the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order has prohibiting the departure from India of the applicant has not been made by any such court.
- h. That the applicant has not been repatriated.
- i. That in the opinion of the central government the issue of a passport or travel document to the applicant will be in the public interest.
- j. That there is no possibility of arising embarrassing position before the government of U.P. due to my visit to any foreign country.
- k. That the issuance of identity certificate for obtaining a passport is never refused to me.
- l. That I have not visited any foreign country yet.
