

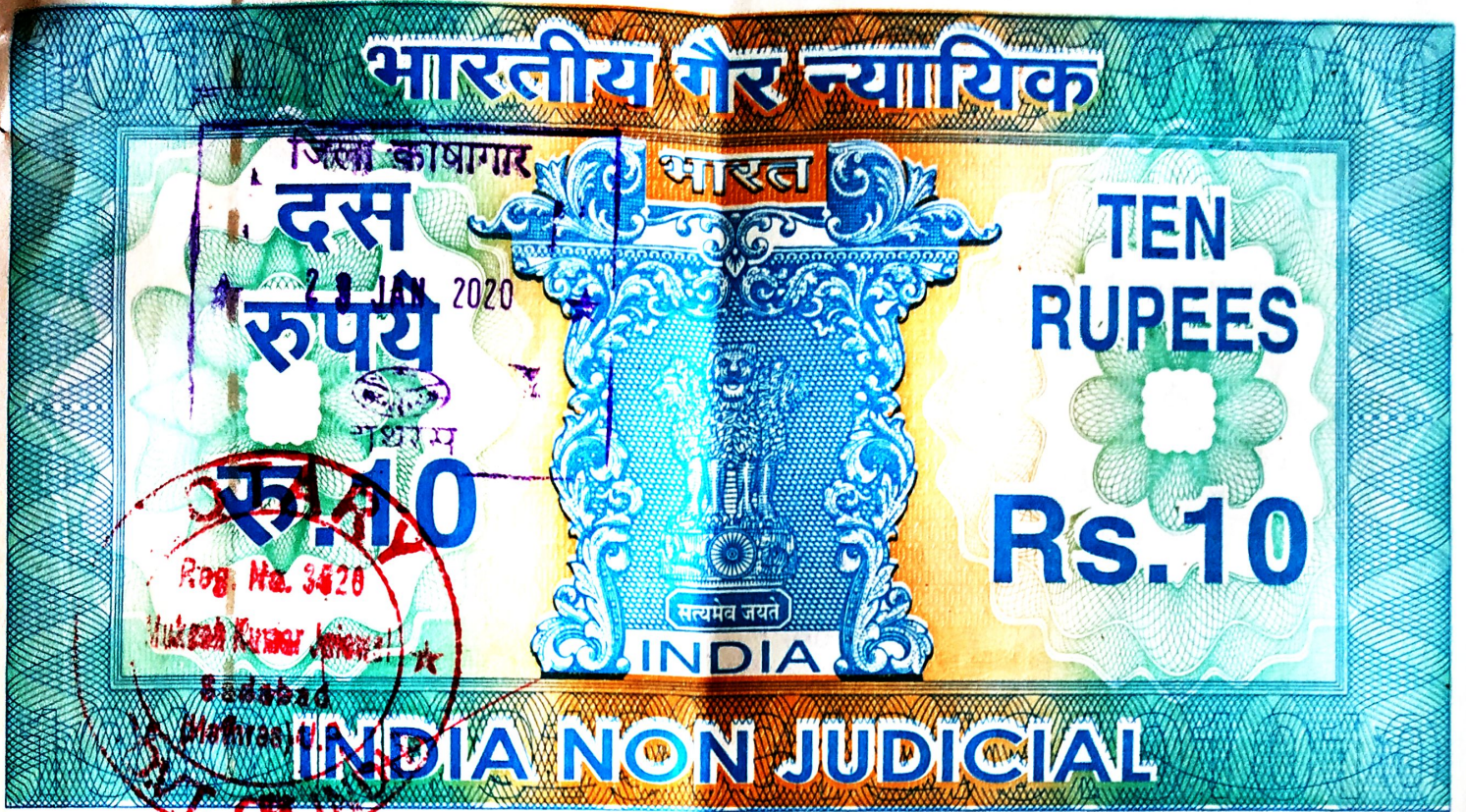
UNDERTAKING IN TERMS OF SECTION 6(2) OF PASSPORT ACT, 1967
