

**Registrar (J) (Budget)**

I have purchased a residential plot measuring 300 sq. mtrs. from Yamuna Expressway Industrial Development Authority, Greater Noida, on 23.12.2019 for Rs. 15,67,500/-

Because of paucity of funds, I chose option for payment of sale/lease consideration in installments spreading over 9 years.

Installment, as per annexed schedule, were paid from my SB Account No. 32549838554.

Hon'ble Court was informed regarding the allotment of the plot vide letter No. 3210/I dated 20.08.2011 and Hon'ble Court vide letter dated 09.09.2011 directed the undersigned to submit the entire facts in the prescribed proforma after registration of the deed.

Ultimately, after paying all the installments, lease deed was executed by the Yamuna Expressway Industrial Development Authority, Greater Noida on 23.12.2019. The total sale consideration is Rs. 15,67,500/-.
