

**Before-Hon'ble High Court of Judicature at Allahabad**


I, Ram Pratap Singh S/O Shri Maharaj Singh, R/O J-33, Judge Compound Kala Aam, Bulandshahr do swear in the name of God that my name and signature and the following contents of my affidavit are true.

The above deponent do swear in the name of God and declare, as per Section 6(2) of the Passport Act 1967, as follows-

- a That the applicant is a citizen of India.
- b That the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
- c That the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India.
- d That the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.
- e That the applicant has, at any time during the period of five years immediately preceding the date of his application, not been convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- f That proceedings in respect of any offence alleged to have been committed by the applicant are not pending before any criminal court in India.
- g That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- h That the applicant has not been repatriated.
- i That there is not any possibility of arising embarrassing position before Government of U.P. due to his visit to any foreign country.
- j That Issue of 'Identity Certificate' for obtaining a passport was never refused to him.
- k That he has never visited any foreign country earlier.
- l That there are five dependent family members- 1. Shri Maharaj Singh (Father) Age about 88 Yrs., 2. Smt. Tarawati (Mother) Age about 86 Yrs., 3. Smt. Sneha Lata (Wife) Age about 46 Yrs., 4. Master Satyam Singh (Son) Age about 16 Yrs. and 5. Master Shreyash Singh (Son) Age about 13 Yrs.
