
महोदय,

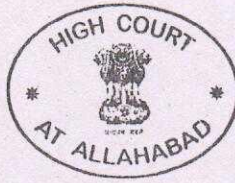




## IDENTITY CERTIFICATE
