Subject- Information of initiation of Talaq proceeding to my wife and request to provide security.

Sir -

It is most respectfully submitted that after my transfer from Banda to Etah in April 2019 I had shifted my family to Lucknow for better education of children. Children were studying in G.D. Goenka Public School Sushant Golf City and family was residing in a rented flat No. A-302 Celebrity Greens Sushant Golf City Shaheed Path Lucknow.

In the last week of November I have got the information that my wife Mrs. Joohi Zama has been in illicit physical relation with some persons . I have got the evidence ,video footage of CCTV and 300+ mobile conversations (which I will produce when needed),which revealed that she was having illicit relations with three persons. I have enquired from my wife and she admitted it before me and even before the witnesses. After watching the video, listening all the mobile conversations and on her admission of having illicit relation with one person for last five years, from Agra and two more persons for last one and half years ,from Banda, I have decided to live separately and pronounce divorce to my wife. She was having illicit relations and it was going on in my rented house also, this will cast shadow on the charecter of my children specially the daughter who is sixteen years old hence for better future ,better upbringing and safety and security of the children I took my all three children to Etah on 2nd of December 2019 and now they are studying in Asissi Convent school Etah. My daughter Ayesha Zama is 16 years old, son Basim Zama is 13 years old and son Aariz Zama is 9 years old . This is pertinent to mention that according to Muslim Law father is legal guardian and will have custody of the children aged eight years or more than that. All my three children are more than eight years.

It is also submitted that due to her illicit relations with other persons and on her admission about the same I have initiated Talaq proceeding . On 11-12-2019 I have pronounced my first Talaq according to valid Muslim Law i.e, Talaq-ul-sunnat (Talaq hasan) . The first pronouncement has been sent by speed post on the addresses of her father and mother who are living separately first pronouncement of Talaq has been recieved. First pronouncement of Talaq has been sent on my wife's e-mail address and by whatsapp and SMS also on her personal mobile number. Talaq Nama has been duly signed by the witnesses also.

It is further respectfully submitted that after first pronouncement of Talaq my wife has started giving several types of threats through her friends and relatives to me and my family members . The threats are ranging from lodging fake F.I.R. , making false complaint to the Hon'ble High Court , complaint to the government and to several commissions. She is also giving threat to my life saying Mukhtar Ansari and several other mafia has close relation with her and her father, and the mafias will kill me . There is danger of my life and family members back home (varanasi) . It is pertinent to mention here that she is daughter of Retired Justice I.M. Quddusi who has very close relation with Mukhtar Ansari And Arun Shankar Shukla Alias Anna Shukla of Lucknow. Mukhtar Ansari was extended on bail by Justice I.M.Quddusi when he was judge of Hon'ble Allahabad High Court and Anna Shukla was Acquitted in a murder case by Justice I.M. Quddusi while he was Judge of Hon'ble High Court Allahabad Lko Bench.

I am being given constant threat by my wife that she will go to any extent to falsly implicate in anything and to finish me off and to kill me , thus it became very important to inform the matter the Hon'ble Court at this level. Hence the information of initiation of Talaq proceeding and information of threat to my life is being submitted for necessary action, future reference and to provide proper security to me and my family.
