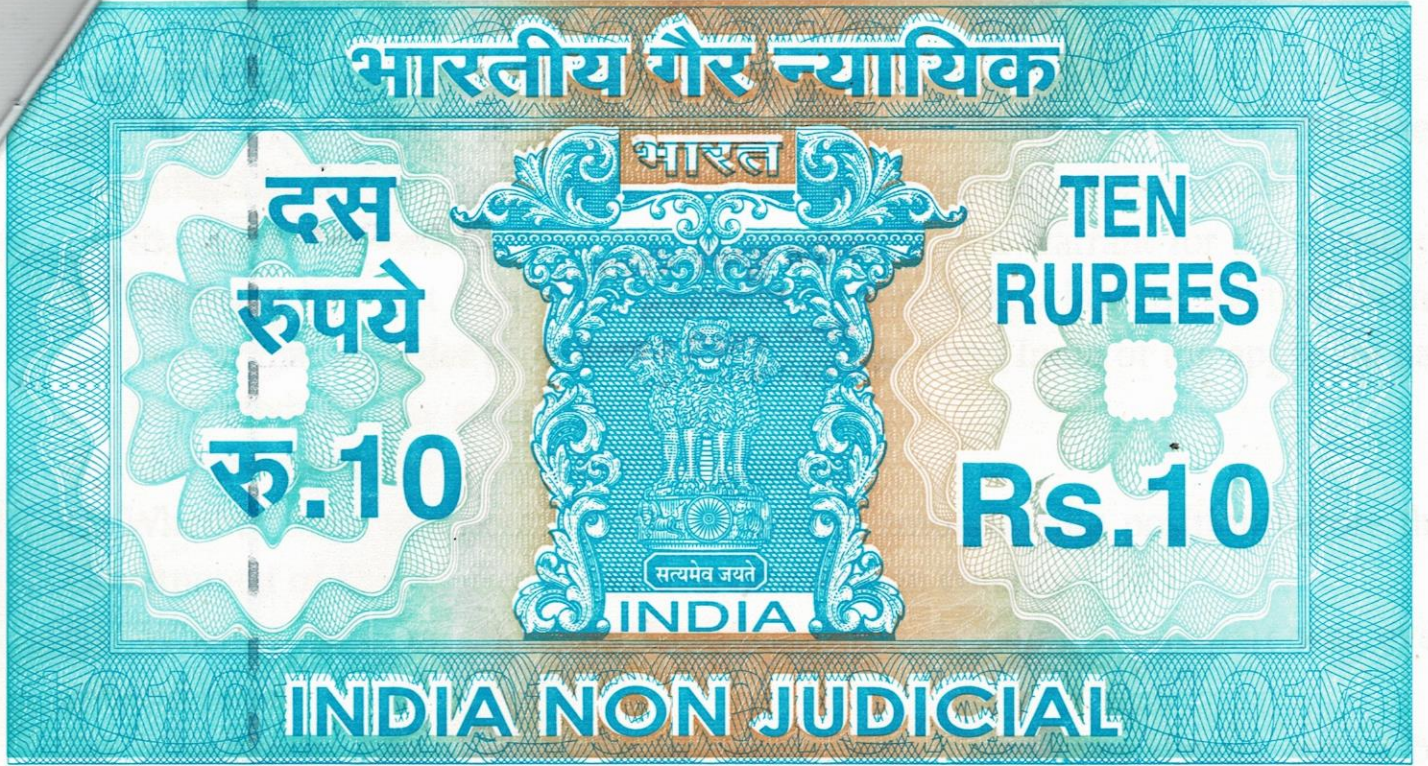

- (a) that the applicant is a citizen of India
- (b) that the applicant may not, or is not likely to engage outside India in activities prejudicial to the sovereignty and integrity of India.
- (c) that the departure of the applicant from India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.

- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.

- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India.
- (g) that a warrant or summons for the appearance or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such Court.
- (h) that the applicant has not been repatriated.
- (I) Whether there is any possibility of arising embarrassing position before the Government of U.P. Due to his visit to any foreign country – NO
- (j) Whether issue of 'Identity Certificate' for obtaining a passport was ever refused to him – NO
- (k) Whether he has visited any foreign country and if yes details are to be submitted-NO
