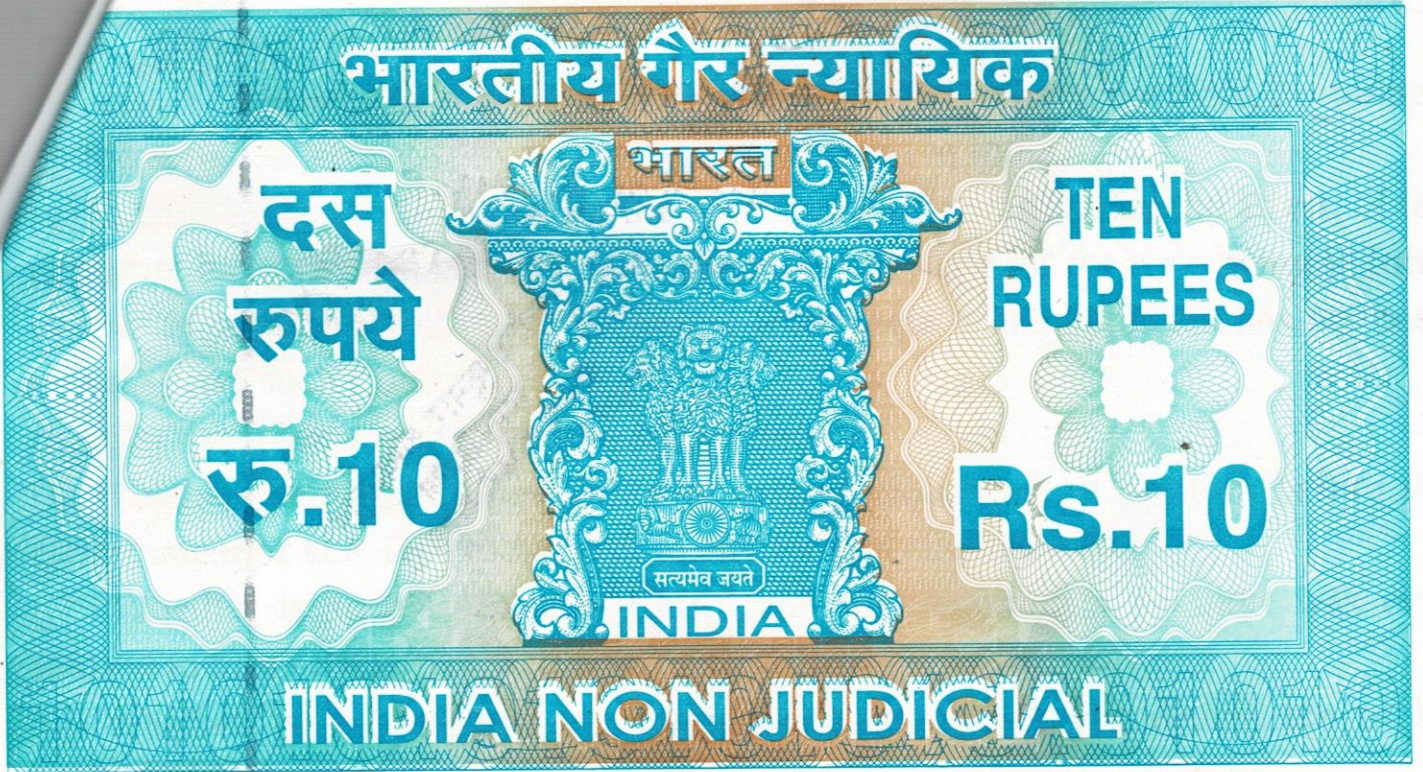

(g) that a warrant or summons for the appearance or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such Court.

(h) that the applicant has not been repatriated.

(j) Whether issue of 'Identity Certificate' for obtaining a passport was ever refused to him – NO
