The applicant is enclosing the requisite identity certificate along with four passport size photograph with the application.


The applicant most humbly requests you to place the application before the Hon'ble Court for appropriate orders, so that he can apply for passport.

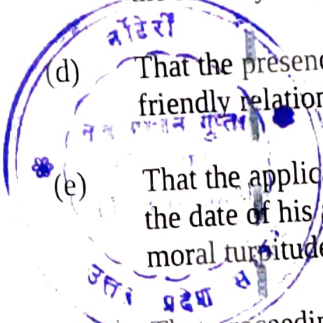
