
AFFIDAVIT

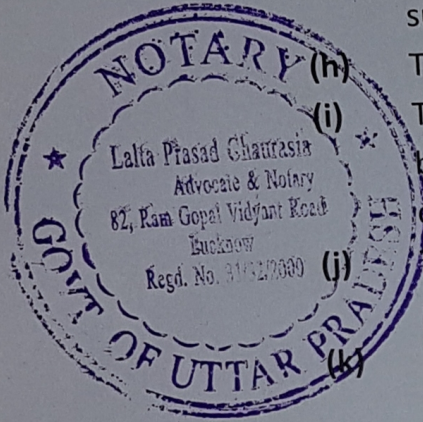
- (a) That the applicant is a citizen of India.



- (e) That the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (f) That no proceedings in respect of an offence alleged to have been committed by the applicant are pending before a criminal court in India.
- (g) That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.



- (h) That the applicant not been repatriated.
- (i) That there is no any possibility of arising embarrassing position before Government of U.P. due to applicant visit to any foreign country.
- (j) That there is no any issue of "Identity Certificate" for obtaining a passport was ever refused to applicant.
- (k) That the applicant has never visited any foreign country.




