Subject- Request of Permission to continue Ph.D. programme.

Respected Sir,

It is most humbly submitted that the applicant had applied for the continuation of his PhD through Letter No. 60/2020 (Admin) Moradabad dated 06.01.2020. In response to which, the applicant was intimated through Letter no. 5603/IV-4947/Admin.(A-4), dated 09.07.2020 of the Hon'ble High Court to furnish details of completion of Course work of the PhD Program.

The course work of the PhD Programme was successfully completed in the period of March 2019-June 2019 much before the joining of the applicant as Addl. Civil Judge (Junior Division) Court No. 3 in Moradabad Judgeship on dated 15.11.2019 vide notification of Hon'ble Court no. 3981/Admin (Services)/2019 dated 14.11.2019. The Transcript of the same was received on 30.12.2019. The transcript of the grades obtained in the course work is attached to the application(Enc. 01).

The applicant shall not require any study leave of any kind whatsoever, as only the presentations are left, which can be given in weeks end, generally 2nd and 4th Saturday. In any case, the applicant would avail his Causal leave, as the presentation is only for a few hours on a given day.

As a part of the Ph.D. Program, three progress reports followed by three presentations are to be given. Due to Covid19 pandemic, the first presentation which was to be given in March 2020 could not be done. The same will be given through Video Conferencing. Hence, the tentative dates to finish the PhD would be December 2021.

As a part of the Ph.D. program, Research assistance is to be satisfied by assisting the Supervisor of the PhD program. The same is a research cum project making exercise in the thrust area of research. The same does not require any attendance in the University and can be submitted online through e-mail to the Supervisor.

It is also to be informed that the nature of work left is the research and writing up of the thesis in MS word format. There are no lectures neither any exam left to be conducted, as the course work is already complete.

By the said research programme my working as a judicial officer in Court shall not be affected in any way.

Therefore, this fact is being brought to the kind notice of the Hon'ble Court and the Hon'ble Court may graciously be pleased to permit me to complete my research programme.
