9. Rohan Motors Limited, is a regular, reputed and registered Maruti dealership.
10. I am in no way related to the proprietor of the Rohan Motors Limited and that none of his cases is pending in my court or decided by me anytime before.
11. Details of the purchase made are as follows:-
 - a) Total cost of vehicle- Rs 8,38,936.63/-+Rs 69,215/-(RTO)+Rs 28,618/-(insurance)+Rs 12,453.72/-(extended warranty)= Rs 9,49,520.35/-. (copy of sale invoice, RTO, Insurance certificate and extended warranty attached).
 - b) Amount paid through RTGS from salary account towards purchase of vehicle- Rs 5,50,000/- (copy of bank passbook attached).
