



Instructions for Newly Appointed officers in The Civil Judge Cadre (2020-21)

(A) GENERAL JOINING INSTRUCTIONS

- Rajasthan State Judicial Academy (RSJA) extends a warm welcome to all the newly appointed officers in the Civil Judge Cadre and wishes them a bright future.
- 2. Every trainee officer shall report on 11.10.2020 at 09:30 am sharp before the District & Sessions Judge (where they will be placed for field training by RSJA) for joining & administration of oath. The formats of Joining, Oath & Personal Information Sheet are available on the official website of RSJA i.e. rajasthanjudicialacademy.nic.in. All the trainee officers are directed to download the same.
- In order to complete the official requirements, every officer must submit following documents (self attested) with the Personal Information Sheet at the time of joining:-
 - (i) AADHAR Card
 - (ii) PAN Card
 - (iii) Savings Bank Account in any of the branches of scheduled bank preferably in SBI.
 - (iv) Proof of Date of Birth viz. Mark Sheet or Certificate of Board of Secondary Education having date of birth.
 - (v) Two cancelled cheque leaves.
 - (vi) Passport size photographs (Two).
- 4. The officers who are already in service of Government/Other organization, should get proper relieving order from their employer and submit the same at the time of joining along with other joining documents.
- 5. The officer who is enrolled as an advocate is advised to complete the formalities regarding suspension of SANAD before joining (if applicable).
- 6. As per approved training scheme, Trainee officers will undergo online training for about 12 days and will subsequently be placed for field training for about 3½ months. Trainee officers will be at liberty to attend 12 days online training either from their place of residence or from the place where they have been attached for field training.

- 7. Since it is a mandatory and extensive training course, no leave shall ordinarily be granted during the period of training.
- 8. The trainee officers are supposed to have with them Civil Procedure Code, Criminal Major Acts and General Rules Civil & Criminal, for ready reference.
- 9. On every occasion related with training (except when specifically exempted) the trainee officers must be wearing the prescribed uniform which is as under:-
- (i) For Female officers: White saree with white blouse or white kurta and white Salwar/white churidar; and black coat
- (ii) For Male officers: White shirt; white/black trousers; black coat; and black tie.
 - The trainee officers are advised to have sufficient sets of prescribed uniform for regular use.
- 10. It shall be the responsibility of the trainee officer to collect stationery items including bag, daily diary and registers at the time of joining.

Conduct & Discipline

- a) Trainee judicial officers shall observe strict discipline during one year induction training. They must be courteous in dealing with the seniors, faculty members, colleagues and the members of the staff. They will do nothing which may disturb others.
- b) Conduct of a trainee officer should always be befitting a judicial officer.
- c) Trainee officers must maintain standard of personal hygiene and social behaviour. They are expected to be punctual and dressed properly.
- d) Trainee officers must keep the surroundings clean and maintain the cleanliness of the rooms and campus where they are staying.
- e) Personal use of mobile phone is strictly prohibited during training sessions.
- f) Consuming alcohol, narcotic drug and smoking is strictly prohibited.
- g) Any violation of the discipline by the trainee judicial officer will be viewed seriously and may lead to termination of his/her services.

(B) GENERAL INSTRUCTIONS FOR ONLINE TRAINING

- After formal joining, the online training will commence on 11.10.2020 at 02:00 pm (11.10.2020 to 23.10.2020). Thereafter, trainee officers shall report for field training before respective District & Sessions Judge on 27.10.2020 at 10:00 am sharp.
- 2. The online training shall be conducted by using the Online Meeting Software Cisco WebEx Meeting Web/Mobile Application.
- 3. Trainee officers are directed to go through the information brochure/user manual and the Video Tutorial of online webinar software well before commencement of the Webinar and to download/install the required software in their Laptops/ Smartphones from the following link. help.webex.com/enus/8bzter/clsco-webex-meetings-video-tutorials.
- 4. User ID/Link, with or without password shall be sent to individual e-mail id or through SMS, as per convenience.
- 5. Trainee officers are directed to report online through feeding User ID/Link, with or without password, as the case may be, at least 15 minutes before the scheduled time. They are advised to use their Smartphone/ Laptop for attending the online training.
- 6. Trainee officers are directed to observe strict discipline & punctuality.
- 7. All the Trainee officers are directed to follow the online training Protocols like:
 - a. Keep their audio mike muted until & unless they are directed by the presenter to unmute them.
 - b. To keep their videos on throughout the training session/sessions. In case any trainee officer is found attending training with his/her video off, it will be viewed seriously.
 - c. Ensure proper Internet connection with adequate data so that training can be attended without any connectivity issue.
- 8. Trainee officers are directed to attend all the training sessions with utmost sincerity & attention. They are expected to be interactive and must be ready & willing to respond to the queries putforth by concerned faculties.
- 9. The trainee officers must be wearing the prescribed uniform during online sessions.

(C) STANDARD OPERATING PROCEDURE/ GUIDELINES REGARDING COVID-19

Looking to the prevailing conditions of pandemic Covid-19, all the Trainee Civil Judges who are expected to join shortly for their one year Induction Training 2020-21, are directed to observe the following measures which are in line with directions/guidelines issued by Central/State Government from time to time:-

- Before joining, trainee officers are directed to get their Covid-19 test done (within 72 hours of the time of reporting) and keep a copy of report with them for producing the same at the time of joining.
- 2. In case any trainee officer is found Covid-19 positive in the test, he/she is directed not to proceed for physical joining and should seek directions from Rajasthan State Judicial Academy while enclosing the Test Report and other relevant medical papers.
- All the trainee officers are directed to install Arogya Setu Application in their mobiles before joining and should update their status in the application on regular interval.
- 4. As far as possible trainee officers are expected to avoid public transportation mode. Trainee officer who has used public transportation mode viz. Flight, Train or Bus will follow the directions/guidelines issued by central/state govt. in this regard.
- Trainee officers are advised to keep with them adequate quantity of personal protective gears viz. Face Mask/ Sanitizer/Gloves/Thermometer etc., as these items are strictly restricted to use for sharing purposes.
- During field training, trainee officers are directed to wear Mask and other required personal protective gear and should follow social distancing norms. Group gatherings shall be prohibited strictly.
- 7. If any Trainee officer is pregnant or a lactating mother or is suffering from medical condition like sever asthama or chronic lung disease/ High BP. Chronic Kidney disease, heart disease, any other medical condition that has potential high risk in the Covid-19 environment in the opinion of medical experts, they are directed to specifically mention their medical condition in the personal information sheet provided by RSJA. Such Trainees should take special care and should keep with them all essential medicines and other required items in adequate number/quantity.

- 8. Trainee officers are directed to maintain a list of persons whom they come in contact on daily basis.
- 9. Trainees are expected to restrict their movement during initial online training and after office hours during field placement to avoid any infection.

During the entire period of training, the trainee officers shall be under the immediate control and supervision of Course Director, Additional Director (Academic), RSJA & under overall supervision & control of Director, RSJA.
