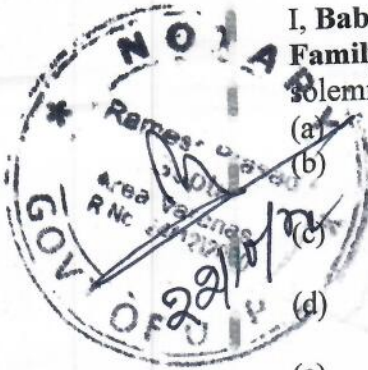

- (h) That the applicant has not been repatriated.
- (i) That there is no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country.
- (j) That the request for issue of 'Identify Certification' for obtaining a passport was never refused to me earlier.
- (k) That I have not visited any foreign country earlier.

I solemnly state that the contents of this affidavit are true to the best of my knowledge and belief and that it coceals nothing and that no part of it is false.

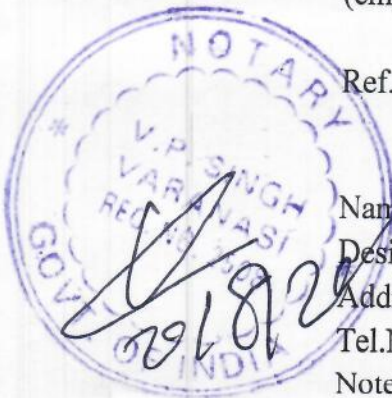
