AFFIDAVIT

Sri Sripati Charan Srivastava, aged about 57 years, permanent resident of 33A, Indira Nagar Colony, Khajuri, Varanasi, posted as Joint Registrar (J) (SCMS) in High Court of Judicature at Allahabad, presently residing at J-7, Judges Colony, 18 Stanley Road, Allahabad, do hereby affirm and declare as under:

- (a) that the deponent is a citizen of India;
- (b) that the deponent may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that the departure of the deponent from India may not, or is not likely to be detrimental to the security of India;
- (d) that the presence of the deponent outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the deponent has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the deponent are pending before a criminal court in India.

(g) that a warrant or summons for the appearance, or a warrant for the arrest, of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such court;

(h) that the deponent has not been repatriated,

(i) that, there is no possibility of arising embarrassing position before Government of U.P. due to deponent's visit to any foreign country.

(j) that, issue of 'Identity Certificate' for obtaining a passport was never refused to the deponent.


(k) that, deponent has never visited any foreign country earlier.






