Affidavit in the matter of:- Issuance of Identity Certificate for obtaining Passport.

I, Lal Bahadur Gond s/o Jawahar Prasad R/o Civil lines, Bageshwar Nagar, Road ways Azamgarh U.P. Pin 276001, Present resident at C-6 Judges Colony Near Sadar Bazar, Jhansi Pin 284001, do hereby solemnly affirm and state as follows:

1. That the deponent is a Citizen of India.
2. That the deponent is not likely to engage outside India in activities prejudicial to the sovereignty of India.
3. That the departure of the deponent from India is not likely to detrimental to the security of India.
4. That the presence of deponent outside India is not likely to prejudice the friendly relation of India with any foreign country.
5. That the deponent has, at any time, during the period of 5 years immediately preceding the date of application, not being convicted by a court in India, for any offence, involving moral turpitude and sentenced in respect thereof, to imprisonment for not less than 2 years. That no proceedings in respect of any offence alleged to have been committed by deponent are pending before any criminal court in India.
6. That a warrant or summan for the appearance of the deponent or for the arrest of the deponent has not ben issued by any court, under any law, for the time being in force or that any order prohibiting the departure of deponent from India, had not been made by any such court.

7. That the deponent has not been repatriated.
8. That the opinion of the Central Govt. The issue of a Passport or a Travel document to the deponent, will be in the public interest.
9. That there is no possibility of arising any embarrassing position before the Hon'ble High Court, the entire Judicial Institution, the Govt. of India, or the Govt. of U. P. due to deponent's proposed visit to foreign countries.
10. That during such proposed foreign visit, the deponent will not indulge in any such activity, that may adversely affect in the International relations of the other country with the republic of India, or tends to tarnish the image of Hon'ble High Court, the entire Judicial Institution, the Govt. of India, or Govt. of U. P.
11. That the deponent has never before visited any foreign country since here to, he does not possess a passport, and has never before applied for the same.
12. That the dependents family members of the deponent are:
 1. Smt. Saroj - wife - 41 Years
 2. Arpit - Son - 15 Years
