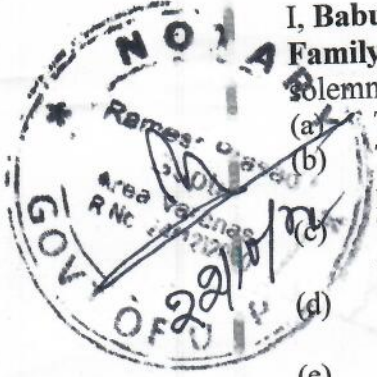

- (a) That the applicant is a citizen of India.

- (e) That the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by court of India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (f) That no proceeding in respect of any offence alleged to have been committed by the applicant is pending before a criminal court in India.
- (g) That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time of being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- (h) That the applicant has not been repatriated.
- (i) That there is no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country.
- (j) That the request for issue of 'Identify Certification' for obtaining a passport was never refused to me earlier.
- (k) That I have not visited any foreign country earlier.

I solemnly state that the contents of this affidavit are true to the best of my knowledge and belief and that it conceals nothing and that no part of it is false.

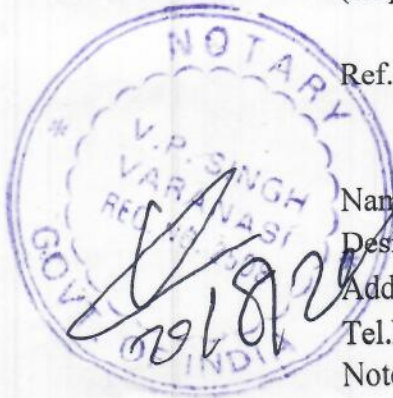
