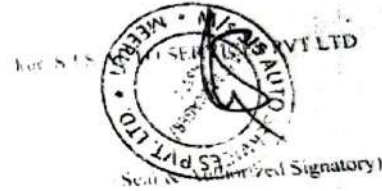

Judicial Officers are not to accept examinership of the University or other bodies of the place of their posting except that of the Public Service Commission.



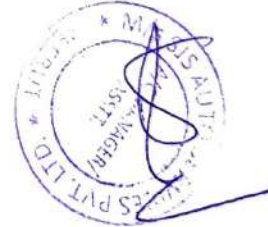
