B. Course Work

- 1) As per the current Ordinance VI-B every student shall undertake course work for a minimum of one semester consisting of courses decided by DRC in consultation with his/her Supervisor. All doctoral students are required to do atleast one compulsory course on Research Methodology based on literature survey, instrumentation, computer applications, data search, presentation skills, writing skills etc. The coursework shall be approved by the DRC and the BRS. Every Department shall notify the list and content of courses for Ph.D. programme on the University website.
- 2) The coursework is transferable between the departments of the University and inter-university subject to their acceptance by the DRC.
- 3) The DRC shall satisfy itself that each student has completed the requirement of course work. The BRS shall provide a certification of completion of course work to each student. If the result is unsatisfactory, the student may be allowed to reappear only once, within one year. If the result is still found unsatisfactory, the DRC would recommend cancellation of his/her registration and this may be reported to the Board of Research Studies. It is clear from above that immediately after joining Ph.D. you have to undertake the course work and on successful completion of the same you would continue with your Ph.D. programme. If the registration is cancelled.

Fellowship

The admission to Ph.D. is presently granted to persons who have been awarded UGC Junior Research Fellowship or are sponsored by fellowship or are awarded the UGC's Non-NET fellowship. Even on recommendation of Non-Net fellowship the disbursement of money may not happen because of financial constraints. There would be no liability of Faculty of Law in this regard but such students recommended for Non-Net fellowship would continue as Ph.D. students. The Ph.D. Students must also comply with the following requirements:

4. Ph.D. is a supervised programme, the candidate has to fulfil the requirement of residency period of two years and no relaxation in this regard can be given to any candidate and should not be treated as part time course. The High Court has also directed that the candidates would comply with the requirement of meeting the supervisor a minimum of thrice a week.
5. The research scholars cannot engage himself/ herself in any gainful pursuit including the legal practice before the Courts. If they engage in any gainful profession including legal practice then their admission to Ph D course would be cancelled forthwith.
6. A Ph.D. candidate who is in employment have to submit the proof of grant of leave from his/her employer for a period of 2 years.

D. The fee shall be deposited with the Cashier, Campus Law Centre, Faculty of Law University of Delhi, Delhi-110007.

E. You are advised to contact the office of the Faculty of Law along with an affidavit (specimen in office), all certificates/testimonials (in Original) in support of educational qualifications etc. before depositing the fee.

F. The effective date of registration would be the date of depositing the requisite fee after completion of all formalities. You are advised to complete all the formalities within one month from the date of issue of this letter. A joining report, duly forwarded by supervisor named herein is required at the time of depositing of admission fee.

G. You are also advised to be in constant touch with your Supervisor and meet him/her at least thrice a week. Your Supervisor has to submit periodical progress report in the Faculty failing which your name may be deleted from the rolls of the Ph.D. students.

You fill in the form and get it scrutinized from Mr. Pant in the Dean's office and a teacher who is member of the DRC together with the Affidavit for not engaging in any gainful activity for a period of 02 years and after that you may deposit the fee together with that form.
