Subject: Intimation regarding pursuing LL.M  
Respected sir,

It is most humbly submitted that vide notification no. 3940 dated 14-11-2019, I Shefali Yadav had joined and taken charge as additional civil judge(J.D) court number 3 meerut, on 16-11-2019. It is pertinent to mention here that, before joining the judicial service I had taken admission in the 3 year LL.M regular course evening batch of 2017-2020 from University of Delhi. This course consists 6 semesters. Now I have to submit my dissertation alongwith that, I will also have to take a few of my pending semester supplementary examinations. It must be noted that I fulfilled all the eligibility requirements which is needed to sit for the examination. When I took charge as Additional Civil Judge(J.D.) I was in the 5th semester of LLM I made sure that I have 66.67% attendance in my 5th semester by attending class till 15 November, 2019 i.e. prior to joining as Additional civil judge(J.D.) 66.67% attendance is the requirement to sit for the LL.M examination. In December 2019 5th semester examination were held but since I did not seek permission from the Hon'ble High Court I could not sit for the examination. For the 6th semester I am only required to submit dissertation there are no

classes being taken for the 6th semester. Therefore, I would not be requiring any additional attendance. These are the following examination for which I repeat, no additional attendance is required on my behalf.

1. Administrative law subject of 1st semester- This is a supplementary paper and would not require any additional attendance.
2. Environmental law subject of 3rd semester- This is also a supplementary paper and would not require any additional attendance.
3. Corporate finance subject of 5th semester- An open book online examination was held for this subject on August 19, 2019 but since I did not seek permission from the honorable High court. I could not sit for the examination. The examination for this particular subject will again be held in May 2021 and I request submission for the same.
4. Corporate management and social responsibility and law of the sea subjects of 5th semester - The 5th semester examination were held in December 2019. But since, I did not seek permission from the Hon'ble High Court I could not sit for the examination. An open book online examination for the first, third and fifth semester exams were held in December 2020 but again I could not sit for the examination since I didn't seek permission. Examination for these subjects will again be held in December 2021 and I request permission for the same.
5. For the 6 semester I am only required to submit dissertation for which I repeat no attendance is required. The same I am required to submit in May 2021.

It is important here to mention that I have not taken any study leave as per the court's C.L. dated 04-11-2011 and neither have I given any exam nor have I attended any class after joining the service. Due to covid-19 pandemic it is difficult for me to collect non attendance certificate.

The complete status of my academic session is as follows:

1st Semester (July- December) 2017 -1st semester consisting of three paper that is comparative constitutional law and governance, intellectual and industrial property law(I), administrative law and regulatory mechanism

2nd semester (January -May)2018 consisting of two paper Law and justice in a global world and intellectual and industrial property law (II)

3rd semester (July - December) 2018 consisting of two paper legal and social science research methods and environmental law

4th semester (January 2019-may 2019)consisting of two paper competition law and corporate finance

5th semester (July 2019-December 2019) consisting of two paper law of the sea and corporate management and social responsibility  
January 2020 and may 2020

6th semester dissertation.

Further, it is respectfully, submitted that my pursuing of L.L.M course would not adversely impact in discharge of my official duty it would rather enhance my judicial aptitude and acumen which would help in discharging my official duties and for the same would require permission from the Hon'ble court is desired.

It is therefore, requested that my application is kindly placed in front of the Hon'ble court for consideration.
