Insured is entitled for NCB upto 90 days of the expiry of the previous policy if there is NO CLAIM on the previous policy.

IN your good letter you have mentioned that Mr. D. K. Agarwal, Agent has done your vehicle insurance, I have called Mr. D.K. Agarwal, Agent regarding the above NCB given on your policy, according to his statement " it was confirmed by insured that there was NO CLAIM on the previous policy issued by National Insurance Company on that basis I have given NCB to the client "

At the time of claim it has come to our notice that you have taken a claim from the previous insurer (National Insurance Company ) and which was not declared by your good self at the time of taking the insurance policy from United India Insurance Company and availed the benefit of NCB from our company, hence the NCB claimed by you was invalid.

Under this circumstances, you are not entitled to any claim in respect of own damage (OD) section under this policy.

We have sent a Regd letter dated 01/11/2013 on your address mentioned on the face of the policy which was returned to our office on 06/11/2013 with a remarks on the letter that "NO SUCH PERSON", we have kept that letter in our file after some days Mr. Alok Tyagi came to our office with your new address and we handed over to him NO CLAIM letter by hand dated 03/12/2013.
