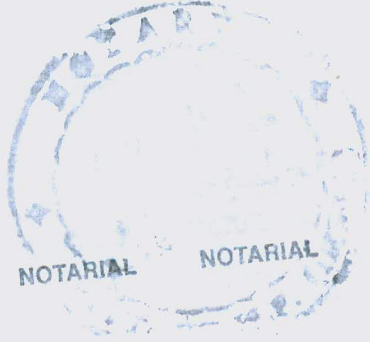

- 13- That I have not visited any foreign country earlier

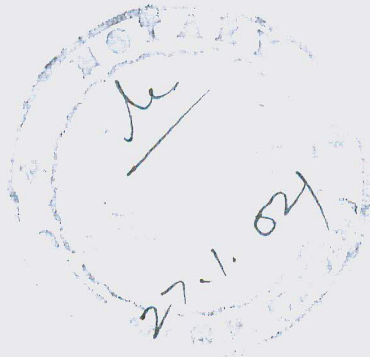




