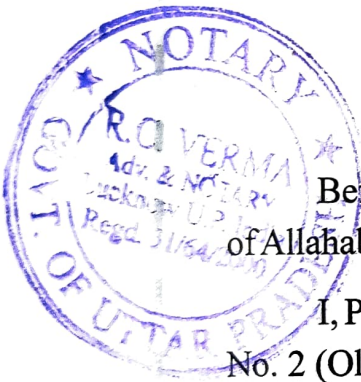




- (f) Proceedings in respect of any offence alleged to have not been committed by applicant are pending before a criminal court of India.
